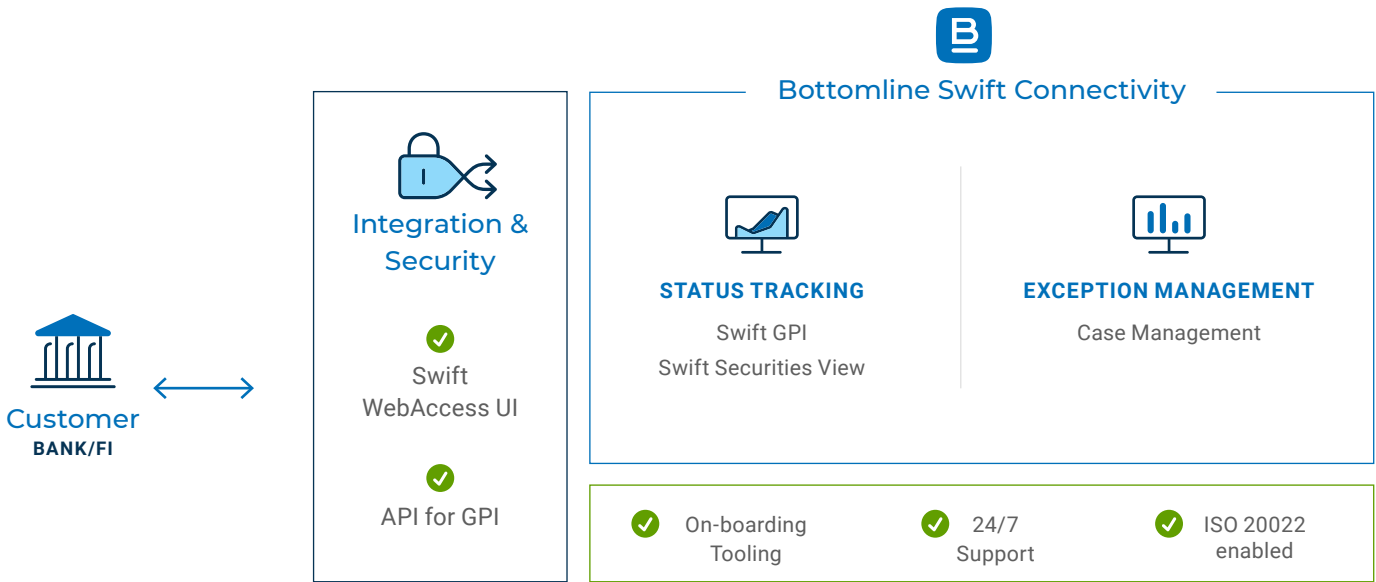

### Swift GPI

Key features of Swift GPI include real-time end-to-end tracking of payments at any stage of the process. Transparency on fees and processing times allows institutions to better manage liquidity alongside offering rapid payments and access to unaltered remittance data.

### Swift Securities View

A collaborative industry solution that aggregates and links key data from securities settlement messages across participants.

Providing a real-time, end-to-end view of the transaction lifecycle, helping users to detect anomalies early, to reduce settlement failures. Such transparency supports compliance with regulations such as CSDR and prepares institutions for shorter settlement cycles.
