## **Step 1: Acquire Vendor Data Safely**

There are two ways we can obtain vendor data.



#### Directly From Your System of Record

By ingesting a vendor history file from your ERP or accounting system—and we can integrate with any ERP--or using a secure file sharing system, we import vendor data directly into our secure portal. We work with your IT team and do all the heavy lifting, and vendors will enter bank account information themselves via our portal.



#### Vendor Self-Enrollment

When you let a vendor know you'd like to pay them through our secure Paymode network, vendors are encouraged to enroll through our secure portal themselves. The process takes less than 15 minutes.

#### **Step 2: Validate Your Supplier Data**

Once we have the data securely in our system, we use in-house expertise and automation to validate your vendor(s) against more than 300 data points. The goal? To ensure the vendor is who they say they are, and that it is not either a fraudulent enrollment or an imposter in your system.

#### Step 3: Hold Vendor Data Securely

The vendor is legitimate and the data's all there, so now Bottomline holds the data. It's protected behind layers of security, including live tracking of anyone attempting to access a vendor record, multifactor authentication for every account, and compliance with key standards like SOC2 and NACHA.

### **Step 4: Protect Payments, Too**

Keeping your vendor data safe is necessary, but we also apply that rigorous level of protection for every payment you issue to vendors. We do so with the same advanced authentication, validation, and monitoring technology and in-house ability we use for your vendor data.
